is required to be attached in the bid documents.

"The Contractor, in preparing the Bid, shall rely on any Site Investigation Reports referred to in the SCC supplemented by any information obtained by the Contractor."

It is reiterated that the contractor shall be deemed to have inspected the site upon submitting the bid.

One of the bidders shared that there is a guideline regarding the SLCC requirement. The SLCC is not required for Small B categories since the Approved Budget for Contract (ABC) is within the Allowable Range of Contract Cost (ARCC).

The bidder shall still submit its Statement of Single Largest Completed Contract (SLCC) similar to the contract to be bid for the purpose of establishing the bidder's track record and capacity to perform the project to be bid.

Moreover, Sec.23.4.2.4 of the 2016 revised IRR provides that,

"The prospective bidder must have completed an SLCC that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid: Provided, however, That contractors under Small A and Small B categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB."

The bidder asked if the biodata of the safety officer would be part of the bid documents. He also asked if it is allowed that the project or materials engineer is also the safety officer.

As long as the Construction Safety and Health Program, regardless if the project engineer is also the safety engineer, is duly approved by the Department of Labor and Employment (DOLE), then this will be the basis of the committee in appreciating the bid.

The said requirement shall be submitted by the winning bidder within fifteen (15) calendar days after contract signing as provided in Section III. Bid Data Sheet (BDS).

Since the plan attached in the bid documents is not clear, the bidder asked if they can have access to the soft copy of the plan.

Electronic clear copy of the plan shall be sent thru email to those who have procured the bid documents.
